BACKGROUND

The new government that came into power in 1994, brought with it changes to the education legislation, which emphasised the parents as important partners for schools. This partnership was formalised by the **South African Schools Act (SASA)**, which identifies School Governing Bodies (SGBs) as official partners in school governance. Thus the new structure of school governance has resulted in the development of new relationship between parent and SGBs collaboration may be viewed as a significant requirement in the relationship between the principal and SGB in order for them to effectively manage their schools financial resources.

CONTRIBUTE A HAND IN EDUCATION ASSOCIATION is mandated to assist the School Governing Body to understand **GOVERNANCE PROCESSES** in strategic and operational management. The distinction between governance and management needs to be clearly understood by all members of the SGBs. The School Governing Body must not be micro-managed. The School Governing Body should concentrate in all matters of the school and must come with a strategist to improve the school for example drafting policies, making judgements about teaching quality, post recruitments and deploying staff below senior leadership level.
